

CALL FOR THE EXPRESSION OF INTEREST
(For the submission of proposals in order to sign a services contract under private law)

The Biomedical Sciences Research Centre «Alexander Fleming» is looking for a post-doctoral research fellow (bioscientist) in the context of the granted project «Innovative products and procedures for diagnosis and cure of common human diseases: an integrated translational research program». The project is funded in the context of the Funding Agreement between the Greek General Secretariat for Research and Technology and SIEMENS SA (22/04/2015) and the Programmatic Agreement between the Greek General Secretariat for Research and Technology and Biomedical Sciences Research Centre «Alexander Fleming» (23/04/2015). Work will take place at the facility of BSRC Alexander Fleming in Vari (Attica), daily between 09:00-17:00, under the supervision of Dr Ch. Savakis.

Position (12 months – possible extension for 12 months – estimated yearly salary cost €26,000)

Subject of the project

The position is on “Development of novel biomarkers for TAUopathies via the Drosophila model” (PI Efthymios Skoulakis). Previous experience associated with the subject of the research project would be an asset.

Required qualifications - criteria

- Bachelor of Science.
- Ph.D in Molecular Biology, Biochemistry or related fields.
- Experience in biochemistry and Tau biology highly desirable. Experience with Drosophila desirable.
- Experience with Confocal microscopy, and statistical analyses.
- Proven research experience and fruitful participation in research programmes.
- Good knowledge of English and communication skills.

Additional qualifications taken into account - criteria

- Previous research experience on the subject of the project
- Previous technical skills associated with experimental models of disease

Candidates must accompany their expression of interest with a detailed CV including research interests, technical skills, publications and contact details of at least two referees.

The evaluation of the submitted proposals will be made by a three-membered evaluation committee.

The candidate who wishes to submit an objection regarding the outcome (decision of acceptance of results) has the right to appeal to the Committee of Research within five (5) days from the announcement of the decision above. The decision of acceptance of

results is announced through its posting on the Transparency Program Initiative (ΔΙΑΥΓΕΙΑ) and on the website of «Alexander Fleming».

Candidates have the right to access their documents and the documents of other candidates by submitting a written application form according to the conditions of article number 5 of the 2690/1999 law (N. 2690/1999 ΦΕΚ Α' 45/9.3.1999).
